She obtained her Bachelor of Arts Degree in European Studies, International Business Track from the Ateneo de Manila University. Ms. Kempeneers is a PARIMA-ANZIIF Certified Risk Professional, a Crisis Management Certified Expert (CMCE) from BCM Institute, and holds a Certificate of the Business Continuity Institute (CBCI).

Ms. Kempeneers is not connected with any government agency or instrumentality, and is not a director of any publicly-listed company.
