Item 9: Other Matters

During its special meeting held on September 27, 2021, the Board of Directors of Aboitiz Equity Ventures Inc. (AEV or the "Company") approved the following:

- 1) The sale or disposal of the Company's 1,840,334,941 common shares in Aboitiz Power Corporation ("AboitizPower"), representing approximately twenty five point zero one percent (25.01%) of the total outstanding common shares of stock of AboitizPower to JERA Asia Pte. Ltd (the "Transaction"); and
- 2) Calling for a Special Stockholders Meeting on December 9, 2021 (the "2021 SSM") to approve and ratify the Transaction, and the appointments necessary in preparation for the 2021 SSM:

- (a) Sale or disposal of the Company's 1,840,334,941 common shares in AboitizPower, representing approximately twenty five point zero one percent (25.01%) of the total outstanding common shares of stock of AboitizPower to JERA Asia Pte. Ltd
- (b) Luis Cañete & Company, an independent auditing firm, to validate the proxies and inspect the counting of votes during the 2021 SSM; and
- (c) The Proxy Validation Committee for the 2021 SSM, consisting of the following officers:
