Item 9: Other Matters

During its regular meeting held today, and upon the recommendation of the Board Environmental, Social, and Corporate Governance Committee (ESCG) Committee, the Board of Directors of Aboitiz Equity Ventures Inc. (the "Company") approved the following:

a. Amendments to the Manual on Corporate Governance:(i) to limit the number of publicly listed company directorships of the Company's Board members; (ii) to revise the quorum requirement for Board meetings and the voting requirements for Board approvals, in accordance with corporate governance best practices; and (iii) to include the duties and responsibilities of the Company's Cyber and Information Security Committee; and

b. Amendments to the Company's General Trading Policy to shorten the mandatory trading blackout period in connection with the disclosure of the quarterly and annual earnings results of the Company.

Copies of the revised Manual on Corporate Governance and Board Cyber and Information Security Committee Charter will be uploaded to the Company's website after editorial comments from the Directors have been addressed.
