## Item 9: Other Matters

On July 17, 2023, Aboitiz Equity Ventures Inc. (AEV) filed an application with the Securities and Exchange Commission (SEC) to issue fixed-rate retail bonds with an aggregate principal amount of up to ₱17.45 billion (bn), inclusive of oversubscription, (the "2023 Bonds"). The 2023 Bonds will be issued as the second tranche of the AEV's ₱30.0 bn shelf registered debt securities program rendered effective by the SEC on November 22, 2022 (the "2022 Debt Securities Program").

Subject to market conditions, the 2023 Bonds are expected to be offered to the general public during the third quarter of 2023. AEV intends to list the 2023 Bonds with the Philippine Dealing and Exchange Corp.
