## **Item 9: Other Matters**

During its regular board meeting held on May 30, 2023, the Board of Directors of Aboitiz Equity Ventures Inc. (AEV or, the "Company") approved the following:

 The issuance by the Company's of fixed-rate retail bonds with an aggregate principal of up to Php17.45 billion, inclusive of oversubscription (collectively, the "Second Tranche Bonds"), from its Php30 billion shelf registration program approved by the Securities Exchange Commission (SEC) in 2022 (the "2022 Shelf Registration Bonds"); 2. Delegated to management (i) the appointment of issue manager(s), bookrunner(s), underwriter(s), and the trustee; and (ii) the final determination of the interest rate, offer price, tenors, and other terms and conditions of the Second Tranche Bonds.

Subject to market conditions, the Second Tranche Bonds are expected to be offered to the general public during the third quarter of 2023 and shall be listed with the Philippine Dealing and Exchange Corporation (PDEx) as and when issued.
